- 3. Horses nominated to the showcase cannot be withdrawn without acceptable veterinary documentation. Entry fee is non-refundable.
- 4. Registered horses must have all original current registration paperwork accompany the entry including a signed transfer by the deadline: April 8th, 2024
- 5. The auction company reserves the right to decline any entry that does not meet minimum standards of compliance. Any entry may be declined at the discretion of sales management.
- 6. Horses will be demonstrated and sold in the same order. Order will be determined by random draw.
- 7. Entry fee \$275.00 per horse and 9.5% commission. No Refunds.
- 8. The highest bidder is to be the buyer. If any dispute arises between two or more bidders, sole authority to settle the dispute is reserved by the auctioneer. The auctioneer reserves the right to reject any or all bids.
